# SUBMISSION TO THE PRODUCTIVITY COMMISSION PUBLIC INQUIRY CARING FOR OLDER AUSTRALIANS

Prepared by Southern Cross Care (WA) Inc. 15 Rowe Avenue, Rivervale, WA, 6103

#### Services in remote areas

Southern Cross Care (WA) Inc. (SCC) currently provides the following aged care services in remote areas:

- 1. 55 residential care beds plus a range of community care programs in Broome servicing predominantly indigenous residents and clients
- 2. 49 residential care beds in Kalgoorlie
- 3. a range of community care services in the Pilbara from service outlets in Port Hedland, Karratha, Tom Price and Roebourne with a large proportion of indigenous clients

SCC has also been granted \$13m of capital funding (\$10m Commonwealth and \$3m State) to construct a 38 bed facility in Carnarvon. This project has not yet been confirmed to proceed due to the fact that, based on current recurrent funding, it would not be operationally viable.

This submission is designed to demonstrate that current funding – capital and recurrent – is inadequate given the realities of service delivery in remote locations.

## **Capital funding**

SCC was fortunate to receive significant amounts of capital funding from both Commonwealth and State governments to construct a residential care facility in Broome. Similarly, the funding for a new facility in Collie (rural rather than remote) was adequate.


It is Southern Cross Care's experience that the amount of initial capital funding for original construction is not the problem.

The issue of inadequate funding for capital items in remote areas is highlighted in:

- the cost of repairs and maintenance and, ultimately,
- how to set aside funds to cover the faster depreciation of buildings and major assets whose useful life, due to climatic conditions, is more limited than that in metropolitan areas.

#### Issues for consideration

a) Below is the Cordell Cost guide for construction in regional centres in WA. The cost impost in Broome (1.45) and Port Hedland (1.58) applies to initial construction but there is also a carry over effect to ongoing repairs and maintenance due to the cost of materials, freight and labour.

b) This is confirmed in Table 1 below which shows the actual price differentials for routine repairs and maintenance between Perth and remote locations.

c) Given current policy settings and funding, it is very difficult to achieve better than break-even before depreciation for residential care in remote locations (see recurrent funding below). How are providers to set aside funds for the replacement of buildings in such circumstances? The solution may lie in amendments to the eligibility criteria for Commonwealth capital grants so that it is possible for providers to apply to be funded for building and asset replacement, even though the particular facility may have been originally funded, in whole or in part, by a capital grant.

The current eligibility criteria are written in such a way that it could be interpreted that funding for replacement would be considered. It is recommended that that possibility be made explicit.

# **Recurrent funding**

As stated above, it is difficult to provide good quality residential aged care services in remote locations given the current funding regime. The Viability Supplement purports to bridge the gap between costs in remote and other locations but is patently inadequate even following significant increases in the last couple of years.

It is well known that the cost of living is significantly higher in remote as opposed to metropolitan locations. Southern Cross Care can demonstrate how this translates for aged care providers:

#### 1. Food and other costs

The following comparisons provide clear evidence of the cost differential on basic goods between Perth and Broome and Perth and Kalgoorlie. These are actual prices paid by SCC to its normal providers in each location.

# 2. Staffing

It is well recognised that residents in care facilities appreciate constancy and stability in staffing – they want to see familiar faces. It is extremely difficult to provide such comfort in remote locations where the population is often transient and the funding regime fails to reflect the realities of providing the quality care which the community expects and the residents deserve.

In most employment categories, aged care providers are competing for staff with the public sector in general and the public health system in particular - a classic case of an uneven playing field.

In addition to salary differentials, there are a number of other employee benefits provided in the public sector making it even more difficult for aged care providers to compete.

The contradiction of the governmen's position is clearly exposed when, by its own actions, it accepts that to recruit and retain its own staff, significant additional benefits have to be provided, yet the cost of providing such additional benefits is not reflected in its funding of aged care providers in those same locations.

# 2.1 Salaries and wages

The most obvious example of the recruitment and retention challenge faced by aged care providers is the comparison of pay rates.

The comparison below summarizes the cost of salaries at Southern Cross Care's Broome facility using current actuals against the cost which would be incurred were Southern Cross Care try and compete by matching public health rates — a variance of over \$270,000 per annum.

#### 2.2 Location Allowances

In many rural and remote locations staff are paid district allowances to compensate them for the additional cost of living expenses.

Recently, the WA Government increased District Allowances to eligible public sector employees. In Karratha, for example, the allowance was increased from \$3,953 to \$9,839 per annum. Those with dependants receive double this amount.

In 2009/2010 Southern Cross Care spent \$63,454 in 'location allowances' in Broome.

#### 2.3 Staff accommodation

In Broome, even the most modest house attracts a weekly rent of \$700. In Karratha, rents of \$2,000 per week for a family home are common.

To deal with this reality, most public sector staff in remote locations are provided with housing or housing subsidies.

We understand that one WA Government department last year paid more than \$500,000 per year in housing subsidies in Broome alone.

Aged care providers receive no realistic supplementation to take account of the real cost of operating in remote locations and are compelled to draw from reserves, should there be any, to remain competitive for staff. In Broome, in order to attract staff SCC invested \$400,000 of its own resources to convert premises to staff accommodation.

# 2.4 Other staffing issues

- Agency staff are typically not available to assist in the maintenance of reasonable staffing levels and standards of care in these locations.
- This results in significant overtime costs which are not reflected in the SCC salary and wages figures above. In 2009/2010 overtime costs in Broome were \$92,278.
- Attracting and retaining a suitably skilled workforce in such locations can be extremely
  difficult and resource intensive. The potential inability to attract and retain a core of
  key personnel facility manager, clinical, registered and enrolled nurses, and allied
  health professionals can leave providers badly exposed introducing fly in-fly out
  arrangements is not unheard of.
- Providing adequate support (e.g. Dementia Consultant) to remote locations is expensive not only in terms of travel and accommodation but also staff time.
- Staff turnover is typically higher in remote locations. This results in additional costs in advertising, orientation and training. In 2009/2010, training costs in Broome were double those of similar sized facilities in Perth.
- SCC has a policy of employing as many indigenous staff as possible, particularly in locations where most of the service recipients are indigenous. This policy results in additional costs in staff replacement, support and training.

## **RECOMMENDATIONS**

This paper has clearly demonstrated the significant financial challenges faced by aged care providers in remote locations. If these challenges are not ameliorated in some way – that means government action – some of those providers may no longer be able to operate in these locations.

It is therefore recommended that:

- 1. Consideration be given to explicitly encouraging providers in remote locations to seek and receive capital funds to address long term replacement of buildings (depreciation).
- 2. Differential funding be provided to operators in remote locations to address the true costs of delivering high quality aged care services.
