SCHOOL EDUCATION (CHAPTER 4)

- The principal focus of this chapter is on government funded primary and secondary school education. Some performance indicators are reported for government schools, non-government schools and school education as a whole (see performance indicator framework on reverse).
- There were 3.4 million full time equivalent school students enrolled in August 2006, in 9612 schools. Of these, 70.5 per cent of primary students and 61.8 per cent of secondary students were educated in government schools (pp. 4.7–8).
- Australian, State and Territory governments spent \$32.4 billion on school education in 2005-06, of which \$25.4 billion (78.4 per cent) was spent on government schools (p. 4.4).


Objectives of school education


- The National Goals for Schooling are presented in the chapter (pp. 4.14–17). In summary, schooling aims to provide education for all young people, by assisting students in:
 - attaining knowledge, skills and understanding in key learning areas
 - developing their talents, capacities, self-confidence, self-esteem and respect for others
 - developing their capacity to contribute to Australia's social, cultural and economic development (p. 4.1).

Government recurrent expenditure per FTE student, government schools, 2005-06^a (p.4.28)



Developments in reporting since the 2007 Report

- This year, the chapter has been enhanced by the inclusion of nationally comparable learning outcomes data for:
 - 15 year old students achieving at or above level 3 on the international assessments for reading literacy and mathematical literacy, 2006
 - students in vocational education and training in schools for 2005
 - Indigenous learning outcomes by geolocation (at a national level only) for 2005. These data provide important information on Indigenous students through further disaggregation of the national learning outcomes data.
