## Errata – Report on Government Services 2008

The following amendments were made to the 2008 Report since it was released in January 2008.

## Chapter 6 — Police services — Deaths in police custody

Text (page 6.56) and table 6.3 (page 6.57) relating to deaths in police custody and custody-related operations have been corrected. The revised text and table are reproduced below.

Nationally, there were 22 deaths in police custody and custody-related operations in 2006. This total comprised 14 non-Indigenous deaths, 6 Indigenous deaths and 2 deaths in NSW for which indigenous status has not been determined. Across jurisdictions, there is a wide variation in the number of deaths (table 6.3).
